The Northeast Area Association 2024 Convention of Alcoholics Anonymous (“NENY24”) respects the privacy of every individual who visits this site. This privacy statement provides notice of the standards and terms under which NENY24 protects the privacy of information supplied by visitors.

The Information We Collect

NENY24 may collect personally identifiable information in a variety of ways, including through online forms and other instances where visitors are invited to volunteer such information.

We may use “cookies” to track how visitors use our website. A cookie is a small file that a web server can store on the visitor’s computer and use to identify the visitor should they visit the web site again.

How We Use Information

NENY24 may use personally identifiable information collected through our web site to contact visitors regarding new activities and services. NENY24 also may use information collected to improve the effectiveness of the web site.

Disclosure of Information

NENY24 does not lend, lease, sell, or otherwise intentionally transfer visitors' personal information to any third party. For online credit card transactions NENY24 employs Square.

To protect Square account holder NENY24 and its convention registrants, all financial information that NENY24 registrants submit through this website is encrypted to Square servers, regardless of whether a registrant is using a public or private WiFi connection or a data service on the registrant's phone (such as 3G, 4G or EDGE). Square complies with all required PCI standards.

Maintenance of Information

The information about visitors and members that is maintained on our systems is protected using industry standard security measures. However, we cannot guarantee that the information submitted to, maintained on, or transmitted from our systems will be completely secure.
